Beijing / Shenyang / Dandong / Changbaishan / Jilin / Harbin + Volga Manor [CBHC]

DAY 1 KUALA LUMPUR > BEIJING

Assemble at Kuala Lumpur International Airport for your flight to Beijing.

DAY 2 BEIJING SHENYANG

[MOB/L/D

- Upon arrival, proceed to the train station for the high-speed train ride to Shenyang, a historic city in Northeast China.
- In Shenyang, explore Zhongjie Pedestrian Street, the most bustling commercial street in Shenyang. It is also the first commercial street in China and is known as the "Number one Street of Northeast China"
- After dinner, check into the hotel for the overnight stay in Shenyang.
- ★ Shenyang Le Méridien Shenyang Heping or similar

DAY 3 SHENYANG A DANDONG

B/I /D1

- After breakfast, visit Shenyang Imperial Palace [closed on Mondays], which was built by the Manchu rulers before they entered central China. The palace, constructed with yellow glazed tiles, appears magnificent and splendid under the sunlight. It holds significant historical value and is the most well-preserved imperial complex in China after the Forbidden City in Beijing.
- Explore Manchu Street in front of the palace, where the buildings mostly follow the architectural styles of Qing Dynasty, giving the street a strong ancient charm. The street sells various crafts, antiques, calligraphy, paintings, and souvenirs, offering a wide range of items for shopping.
- Next, visit Marshal Zhang's Mansion [closed on Mondays]. This was the official residence and former home of Zhang Zuolin, the leader of the Fengtian clique warlords, and his son, the patriotic general Zhang Xueliang. The mansion includes traditional Chinese courtyards with intricately carved beams and painted rafters, grand European-style buildings, and a garden with pavilions and water features, all of which are very impressive and unique.
- Continue on to the Former Residence of Zhao Yidi, commonly known as Ms Zhao Si's Mansion. This elegant European-style building is a historical site that witnessed a legendary romance from the Republican era and is an important part of the Zhang Family Marshal Mansion Museum, a nationally protected cultural site.
- Take a stroll along Andong Old Street, which replicates iconic old buildings, traditional street names, and decorations from the past. It combines nostalgia, classic cuisine, sightseeing, and shopping.
- After that, head to Dandong City for an overnight stay.
- ★ Dandong Hilton Garden Inn or similar

DAY 4 DANDONG TONGHUA CITY

[B/L/D]

- After breakfast, proceed to Yalu River Park the riverside scenery along the Yalu River Park is beautiful, serving as the natural border between China and North Korea.
- Enjoy a boat ride on the Yalu River, where you can not only see the historic Broken Bridge of the Yalu River, a key site from the Korean War, but also get a rare look at North Korean life—including military camps, watchtowers, soldiers on guard and patrol, as well as scenes of local workers and civilians going about their daily lives.
- Next, visit the Memorial Hall of the War to Resist U.S. Aggression and Aid Korea [closed on Mondays], a museum dedicated to the Korean War. Through its extensive collection of artifacts, photographs, and multimedia exhibits, the museum vividly recounts heroic stories from that time.
- After dinner, enjoy a night stay in Tonghua City.
- * Tonghua City Zhongdong Latour Morgan Hotel or similar

DAY 5 TONGHUA CITY A CHANGBAISHAN

[B/L/D]

- After breakfast, visit the Changbaishan Scenic Area [shuttle and eco-friendly bus rides included]. Changbaishan is a dormant volcano that has erupted several times in history, creating unique geological features and making its natural landscape exceptionally beautiful and diverse. The main attraction is the highest crater lake, Heaven Lake, also known as Mt. Baekdu, a majestic and beautiful lake located on the border between China and North Korea.
- Next, head to Lvyuantan [Green Abyss Pool], a clear and emerald-green pond within the scenic area. Its water is so pristine and colorful that it resembles the famous Jiuzhaigou, earning it the nickname "Little Jiuzhaigou of the Northeast." Nearby, visit the Changbai Waterfall, where water flows directly from the Tianchi Lake, plunging down a cliff with a thunderous roar, an awe-inspiring sight.
- After that, explore Julong Hot Spring Group, known as the Number One Spring of Changbai Mountain. This large, widely distributed hot spring area features high-temperature water that can boil eggs in just a short time. The springs, formed over many years, are rich in minerals and trace elements [Each customer will receive one egg boiled in the hot spring water].
 - **Note:** Visits to some scenic spots within the Changbai Mountain area are subject to weather conditions.
- After dinner, check into a hot spring hotel, where you can enjoy the hot spring baths [please bring your own swimsuit].
- ★ Changbaishan Dongwo Hotspring Hotel or similar

DAY 6 CHANGBAISHAN 🗐 JILIN

[B/L/D]

- After breakfast, visit the **Korean Folk Village**, also known as the Orchard Korean Folk Village, which showcases traditional Korean-style homes, decorative archways, water wheels, squares, courtyards, and other beautiful elements—creating a poetic, picturesque borderland atmosphere. During the visit, you'll also get to taste authentic Korean ethnic foods such as tteok [Korean rice cake], kimchi, and explore local homes.
- Next, visit the Rime Ice Museum, China's first indoor museum simulating rime frost. The indoor temperature is maintained at around -6°C, realistically recreating the stunning "tree frost spectacle," and simulating the rime ecosystems found in Changbai Mountain and the Songhua River, displaying shimmering frost on willow branches and pine forests.
- Along the way, enjoy a scenic drive along Songjiang Middle Road, taking in the beautiful views along the Songhua River.
- Then, view the **Jilin Catholic Church** from the outside a classic example of Gothic architecture. The church, with its main building and bell tower, has a cruciform layout and is constructed entirely of brick and stone, without wooden beams or columns.
- > After dinner, enjoy a night stay in Jilin.
- ★ Jilin Ramada Hotel Jilin Purple Garden or similar

DAY 7 JILIN 🗖 HARBIN

[B/L/D

- After breakfast, drive to Sun Island Park on the north side of the Songhua River. It is a world famous summer resort, known for its charming scenery and relaxing atmosphere.
- Visit the Indoor Ice and Snow Dreamland, which features over a hundred ice and snow sculptures. The indoor temperature is maintained year-round between -5°C and -10°C, making it the largest indoor ice and snow sculpture exhibition hall in the world.
- View the exterior of Harbin Grand Theatre, a landmark building in Harbin designed to reflect the northern landscape [Due to irregular schedule in performance, the visit is just for exterior viewing and photography].
- In the afternoon, head to Saint Sofia Square to view the iconic Saint Sophia Cathedral, known for its strong exotic atmosphere. It was once the largest Eastern Orthodox Church in the Far East with typical Byzantine architecture.
- Explore Central Avenue [Zhonyang Dajie], the longest and largest pedestrian street, famous for its architectural styles and unique cobblestone pavement, stretching for a length of 1450 meters. Here, don't miss the must-try local highlights the century-old Madie'er Popsicle.
- > After dinner, stay overnight in Harbin.
- * Harbin Crowne Plaza Hotel or similar

DAY 8 HARBIN A VOLGA MANOR HARBIN

[B/L/D

- After breakfast, make an excursion to Volga Manor, located along the Ashi River in the outskirts of Harbin. This Russian-themed park is based on Harbin's history and filled with exotic charm. Begin by exploring several iconic Russian-style buildings within the manor, such as St. Nicholas Church, Pavlov Castle, Pushkin Salon, and the Petrov Art Gallery. Then, visit the neighboring Russian Folk Culture Village, a themed street designed to showcase traditional Russian customs, architecture, crafts, and daily life. Stop by the Unicorn Forest Horse Ranch, where you can take photos with the whimsical Oriental unicorn-themed slide and enjoy cute horse-riding scenes in a forested setting perfect for fun and memorable pictures.
- Explore the Lao Daowai Baroque Architecture District, the birthplace of Harbin's ethnic industry and commerce. It features the largest and best-preserved cluster of Chinese Baroque buildings in existence.
- > After dinner, return to hotel for another night stay in Harbin.
- ★ Harbin Crowne Plaza Hotel or similar

DAY 9 HARBIN - BEIJING

[B/D]

- After breakfast, take a high-speed train back to Beijing.
- Upon arrival, visit Beijing's famous Qianmen Street, a commercial street lined with century-old shops and ancient buildings. The street features traditional archways, old signs, and red lanterns, showcasing the character of the ancient capital with a strong feel of old Beijing.
- Then, stroll through **Dashilar**, Beijing's oldest and most unique commercial street.
- Next, visit the nearby Xianyukou Food Street, which gathers many time-honored food brands. The short street is lined with various eateries, offering a rich local characteristics.
- After dinner, check into the hotel for the overnight stay in Beijing.

Passengers are deemed to have read, understood and accepted the following conditions. The organizer shall be known as "The Company" in the conditions below.

RESERVATIONS AND DEPOSIT

A deposit of RM 500 - RM 3,000.00 (subject to tour package selected) is required upon booking. The balance is to be paid in full 35-40 days before departure. Failure to comply with this may result in an automatic cancellation of reservation and a forfeiture of deposit. Deposits are applicable for the tour booked only and are not transferable.

CREDIT CARD / CHARGE CARD

An administrative fee is chargeable for payments by credit or charge card.

CANCELLATION / AMENDMENTS

- 1) Cancellation of a confirmed booking must be made in writing to avoid misunderstanding.
- Postponement / transfer of tour will be deemed to be a cancellation and will be charged accordingly.
- 3) Cancellations during peak, festive or holiday seasons will result in 100% forfeiture of the booking deposit.
- 4) For each amendment made after a booking has been confirmed, a fee will be charge by the respective airlines and service suppliers. An amendment does not constitute a transfer to another tour.
- 5) Deposits paid during travel fairs are non-refundable and will be forfeited if passenger cancels tour

The Company shall henceforth not bear any other liability or responsibility.

TOUR FARE INCLUDES (GROUP TOURS ONLY)

Unless stated otherwise, the fare includes:-

- Return economy class group tour air ticket.
- Return airport transfer (airport to hotel and vice-versa)
- Hotel accommodation on twin-share or triple-share basis. Single room occupancy is at additional cost.
- When booking triple-share rooms please note that third bed may be a "roll-away" bed.

Tour fares are based on current airfares, service prices, government tax and exchange rates, applicable at time of print or quotation and are subject to change with or without prior notice.

CHILD FARE

Eligibility: Below 12 years (on the date of departure) Child fare is based on sharing a room with two adults. There will be an additional cost for child sharing one room with an adult.

ACCOMMODATION

In the event the accommodation booked or requested is not available, every effort will be made for an alternative accommodation of similar standard. The Company shall henceforth not bear any other liability or responsibility.

SPECIAL REQUEST

TRAVEL DOCUMENTS

It is the passenger's responsibility to ensure that his/her international passport has a validity of at least 6 months from the date of departure. Relevant visas and vaccinations may be required. An administrative fee of RM50.00 per person will be levied for any cancellation due to non-approval of visas.

The Company will, wherever possible, assist you to obtain the necessary visas. Service charge and visa fees will be borne by the passenger. The Company does not guarantee the approval of the visa application. If for any reason, application for visa or exit permit is rejected, a full refund of all monies paid (excluding visa application fees) will be made, if the result of the rejection is made known to the Company at least 30 days prior to departures.

The Company cannot be held responsible for any expenses, reimbursement or refund of any tour fares if passenger is refused entry by any country on the tour for whatever reasons, including lack of necessary visas.

SEAT ROTATION

For the convenience of all members of the group, passengers are requested to rotate their seating arrangements on the coach during the period of the tour. Please co-operate when called upon to do so by the tour leader/guide.

TRAVEL INSURANCE

Strongly recommended with respect to such areas as trip cancellation, personal baggage, personal accident, injury and illness. Under no circumstance is The Company to be construed as a carrier under contract for safe carriage of the passenger or her/his baggage and belongings. Our staff will be pleased to assist in the enquiries of any travel insurance.

EXTENSION OF STAY / DEVIATION

Extension of stay / deviation may be permitted at the end of the tour, subject to validity and restrictions of air ticket, seat confirmation and availability of hotel prior to the commencement of tour. It is the passenger's responsibility to hold firm confirmation for their return flight. When extension of stay / deviation cannot be confirmed three weeks prior to the group's departure date, the passenger is deemed to be taking the original tour schedule. In the event that the original arrangement has been changed by The Company during the process, any extra cost will be borne by the passenger.

Extension of stay / deviation will be at the passenger's own expense and transfer to airport will not be provided. Alteration on the routing or date of travel is at the passenger's own risk. No refund will be made to such a person for unused air tickets or for any meals and sightseeing tours or accommodation not used in part or full.

The air ticket issued is a special ticket, restricted to a specific airline only. It is non-negotiable, non-endorsable, non-reissuable, non-refundable and non-reroutable.

RESPONSIBILITY
